RESOLUTION NO. 6-25

A RESOLUTION TO OPEN ALL-TERRAIN AND UTILITY TERRAIN VEHICLE ROUTES AND SET THE EFFECTIVE DATES FOR ORDINANCE NO. 9-24 AND ORDINANCE NO. 5-25b IN THE TOWN OF OTTAWA

WHEREAS, the Town of Ottawa recognizes that surrounding communities permit the use of nontraditional vehicles, including all-terrain vehicles and utility terrain vehicles, on their roadways; and

WHEREAS, the Town of Ottawa recognizes that there is interest in allowing the use of such vehicles on roadways within the Town; and

WHEREAS, the Town Board of the Town of Ottawa adopted Ordinance No. 9-24 repealing and recreating its ordinance regulating All-Terrain Vehicles and Utility Terrain Vehicles as approved by the Town Board on September 10, 2024 and Ordinance No. 5-25b repealing and recreating portions of the All-Terrain Vehicles and Utility Terrain Vehicles Ordinance regulating signage for All-Terrain and Utility Terrian Vehicles on May 12, 2025, but the same ordinances do not become effective until the satisfaction of the conditions specified therein; and

WHEREAS, one of said conditions in Ordinance No. 9-24 and Ordinance No.5-25b is that the Okauchee Area ATV/UTV Club must purchase and stake out the placement of all signs required by State Law, and the Town Board approving the location of the signs and the signs having been fully placed and accepted by the adoption of a Town Board resolution; and

WHEREAS, The Okauchee Area ATV/UTV Club has advised the Town Board that it has purchased and placed signage as agreed upon and required in Ordinance No. 9-24 and Ordinance No. 5-25b; and

WHEREAS, Town Staff and/or the Town Board have had the opportunity to inspect the signage placed by the Okauchee Area ATV/UTV Club for compliance with state statutes and Ordinance No. 9-24 and Ordinance No. 5-25b.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Ottawa, Waukesha County, Wisconsin that the Town Board, having had the opportunity to review the placement and nature of All-Terrain and Utility Terrain Vehicle route signage by the Okauchee Area ATV/UTV Club, determines the signage meets the requirements and conditions of Ordinance No. 9-24 and Ordinance No. 5-25b such that in accordance with the "Effective Date" Sections of those Ordinances, such that Ordinance No. 9-24 and Ordinance No. 5-25b shall have an effective date as the date of the approval and adoption of this Resolution.
